NABP Website Linking Request

Policy on Linking to Websites Operated by the National Association of Boards of Pharmacy

The websites operated by National Association of Boards of Pharmacy® (NABP®) exist to advance the mission and objectives of the Association. The web pages provide a service to NABP members. The opportunity to establish email and web links is available to members. The Association will allow others to link to its website after review and approval by the Executive Director/Secretary.

Under this policy, members and non-members may have links to NABP websites if they meet the following criteria:

- their site will be used in a manner consistent with all state and federal laws;
- their site will be consistent with NABP's mission statement; and
- their site will not violate or infringe upon any copyright, trademark, patent, or proprietary rights of others or contain anything obscene, discriminatory, or intended for harassment purposes.

Links may be broken by NABP if the linking site fails to meet these criteria.

Process:

Members and non-members seeking to establish links to NABP websites shall submit a request in writing to the Executive Director/Secretary. The Executive Director/Secretary will evaluate the potential linked site according to these criteria and inform the requester whether their site may be linked to the requested NABP website(s).

If the requester chooses to link a site to an NABP website, he or she will sign an agreement with NABP which will specify that:

- the site will be used in a manner consistent with all state and federal laws;
- the site will be consistent with NABP's mission statement;
- the site will not be transferred to any other entity without allowing NABP the opportunity to review the entity's compliance with the NABP criteria described above; and
- the site will not violate or infringe upon any copyright, trademark, patent, or proprietary rights of others or contain anything obscene, discriminatory, or intended for harassment purposes.

Decisions of the Executive Director/Secretary will be final.
