Renewal Reminder

It is that time of year to verify and renew your license(s) and/or permit(s). Please verify whether your license/permit's expiration date is upcoming. If your license or permit is due to expire at the end of October 2022, you will need to renew it. Beginning November 2022, you will incur a renewal late fee, and in addition, if you work with an expired license or operate with an expired permit, you may be in violation of Arizona law. For licensees, prior to renewing your license, please ensure you have all your continuing education requirements completed.

Welcome New Board Members



Frank Thorwald is managing member of The Thorwald Group, LLC, and is the governor's official representative to the Interstate Oil and Gas Compact Commission. He is also chairman of the Arizona Oil and Gas Conservation Commission and a member of the Governor's Regulatory Review Council. Frank has served three governors of Arizona on the Council on Workforce Policy; Governor's Transportation Vision 21 Task Force; and the Commerce and Economic Development Commission.

He produced and directed numerous national and international media campaigns. He was acting department assistant secretary for public affairs and legislation at the US Department of Education and served as consultant to the inspector general. He advised the director of the Office of Review and Oversight at the Department of Defense (DOD), now the Inspector General's

Office of Congressional Relations, for all DOD departments. Frank also represented the White House and the Justice Department in more than 67 countries with heads of state, cabinet officers, and the news media. He has provided logistics services for US presidents, cabinet, diplomatic missions, and large complex events. Frank has worked with Hollywood celebrities and cabinet wives on a variety of endeavors and had the honor of meeting Pope John Paul during a diplomatic mission to the Vatican.

Frank has worked with world leaders, Fortune 500 CEOs, and senior executives creating solutions on a variety of issues, including politics, legislation, internal communications, media campaigns, international relations, technology, transportation, regulatory, economic/business development, and trade issues. As president of corporations, he has provided unparalleled leadership, and as a chief operating officer, his direction avoided the pitfalls of a rapidly growing company generating sales of \$19 million per month. He serves on numerous corporate boards and is active in community improvement.

"I'm confident that RHGI will build upon our accomplishments and embrace the island spirit that has continuously guided everything our team members do."

Schedule II CS Prescriptions

Board staff is receiving calls and emails inquiring about the continued ability for pharmacists to document certain information on prescriptions for Schedule II controlled substances (CS), such as patient address.

21 Code of Federal Regulations (CFR) 1306.05(A)

A.R.S. 362525

A federal law enacted in 2019 required all federal agencies to undertake review of various informal guidance documents. As a result of this review, Drug Enforcement Administration (DEA) removed informal guidance from its website concerning changes to prescriptions for Schedule II CS. The National Association of Chain Drug Stores issued a letter on June 17, 2022, describing a private phone call with DEA officials. The letter indicated that, despite DEA's historical guidance permitting pharmacist annotations to Schedule II CS prescriptions, all prescriptions for Schedule II CS must now arrive at the pharmacy with all elements required by 21 CFR 1306.05(A) in final form.

NABP is sharing the attached guidance document from DEA which addresses changes pharmacists may make to Schedule II paper prescriptions. DEA will provide the guidance document to DEA-registered pharmacies via email. A **Prescriptions Q&A** is also posted on the DEA Diversion website.
