COVID-19 PHE and COVID-19 Vaccines

The coronavirus disease 2019 (COVID-19) public health emergency (PHE) has facilitated the government's response to COVID-19. This declaration, along with the Public Readiness and Emergency Preparedness Act (PREP Act), allowed many new opportunities for pharmacists and pharmacy support personnel. With the conclusion of the PHE, it is important to remember how we can best serve our patients under these changes. At the time of this submission, the

United States Department of Health and Human Services (HHS) Secretary Xavier Becerra has committed to the following:

- Where immunity from liability will be extended until December 2024 to pharmacists, pharmacy interns, and pharmacy technicians:
 - to administer COVID-19 and seasonal influenza vaccines to those three and over (consistent with other requirements); and
 - COVID-19 tests
- · No change to "Test to Treat"
- No change to coverage for dispensing of COVID-19 antivirals
- Once products are no longer distributed by the government, the following will cease:
 - COVID-19 vaccination by nontraditional providers (recently retired providers and students)
 - COVID-19 vaccinations across state lines by licensed pharmacists and pharmacy interns
 - · Coverage for routine childhood vaccinations

It is important to stay up to date on all matters related to COVID-19 as authorizations will change. Pharmacy personnel may access HHS updates here. COVID-19 vaccine administration and schedule information can be found at Food and Drug Administration and Centers for Disease Control and Prevention. And always be sure to check important announcements from the District of Columbia Department of Health. Thank you for serving the residents of DC.

Narcan Soon Available OTC

Narcan®, naloxone 4 mg nasal spray, is used to rapidly reverse the effects of a drug overdose and will soon be available without a prescription. Availability of over-the-counter (OTC) products will depend on the manufacturer, Emergent BioSolutions, who have said they are targeting late summer. Injectable forms of naloxone and other brands will only be available with a prescription.

Naloxone is currently available at no cost, ID, or prescription in every ward in the District of Columbia. More information regarding naloxone in DC can be found here.

Board of Pharmacy Consumer Members

The Board is currently accepting applications for two consumer Board members. Appointment to the Board is through the Mayor's Office of Talent and Appointments (MOTA). Requirements for consumer members include:

- · DC residency;
- · shall not be a health professional or in training to become a health professional; and
- shall not have a household member who is a health professional or is in training to become a health professional.

If you are interested, or know someone who may be interested, visit MOTA for an appointment application. Appointments to the Board are for three years.
