Update to Vaccinations and Immunizations in the District of Columbia

On June 22, 2023, the interim director of the Department of Health adopted an emergency rule regarding Chapter 65 (Pharmacists) of Title 17 (Business, Occupations, and Professions) of the District of Columbia Municipal Regulations.

This will now allow pharmacists certified by the Board to give immunizations and vaccinations recommended by the Advisory Committee on Immunization Practices to children ages three through 17 years, with parental consent. Before the COVID-19 pandemic, District of Columbia-licensed pharmacists were only able to give vaccinations to children ages 12 years and older.

The emergency rulemaking also allows registered pharmacy technicians and pharmacy interns to administer COVID-19 vaccinations and seasonal influenza vaccinations, while under a pharmacist's direct supervision, to individuals ages 18 years and older. It is important to note that a written protocol and prescription or standing order with a District of Columbia-licensed physician will be required for pharmacists to administer immunizations, with the exception of COVID-19 vaccinations and seasonal influenza vaccinations.
