NABP/AACP Districts 1 & 2 Meeting Update

District 2 hosted the joint National Association of Boards of Pharmacy® (NABP®)/American Association of Colleges of Pharmacy (AACP) Districts 1 & 2 Meeting in Atlantic City, NJ, September 20-22, 2023. State board of pharmacy and college of pharmacy representatives from Maine to Virginia met for *Advancing Our Profession Through Pharmacy Collaboration*; the District of Columbia's delegation included Drs Allison Hill, Tamara McCants, and Justin Ortique. The NABP/AACP District Meetings convene regional pharmacy stakeholders for updates on regulatory, educational, and practice of pharmacy issues. Attendees were privileged to attend session topics on *Collaboration in Advancing Pharmacy*; *Revolutionizing Pharmacy Practice: Embracing a New Paradigm*; and *Past, Present, and Future: Shifting Paradigms in Pharmacy Practice and Education*. Trending topics, such as compounding and the Drug Supply Chain

Security Act, were also explored. Evening networking receptions were held at the Steel Pier and Hard Rock Hotel & Casino and included a performance by The Hashtags, whose lead singer was a pharmacy technician. Congratulations to Dr Ortique, who was elected to serve as the District 2 representative on NABP's Committee on Resolutions, and Dr Hill, who will continue serving as District 2 secretary/treasurer. Health Professional Licensing Boards Residency Requirement Amendment Act of 2023

The Health Professional Licensing Boards Residency Requirement Amendment Act of 2023 was introduced on June 2, 2023, which would allow non-District residents to serve on health professional licensing boards. Restrictions include requirements for the Board chair and consumer members to be District residents, and no more than 50% of the Board could be made up of non-District residents. Mayor Muriel Bowser signed the bill on November 21, 2023, and it became law on January 23, 2024.
