Significant Adverse Drug Event

1. A 71-year-old male attempted to pick up a refill for atenolol 100 mg but was given allopurinol 100 mg instead. After taking three doses, the patient reported tachycardia, dizziness, and an increase in his anxiety symptoms. The pharmacist attributes the error to skipping a final barcode scan and to similar-looking stock bottles, as well as similar size, color, and appearance of tablets. The pharmacy is now requiring markings

on filled prescriptions near the National Drug Code when filling and during the final check.

Drug Enforcement Administration Reminder: CS Prescriptions Can Only Be Sent to Patients

Delivering patient-specific controlled substance (CS) prescriptions to practitioner offices is **not** in compliance with federal regulations (unless excepted, eg, Sublocade®). To learn more, refer to the United States Code (USC) here.

21 USC §829a (a)(5): "The controlled substance is to be administered only to the patient named on the prescription not later than 45 days after the date of receipt of the controlled substance by the practitioner."

Centralized Prescription Dispensing

- (a) "Centralized prescription dispensing" means the dispensing or refilling of a prescription drug order by a retail or nonresident pharmacy.
 - (1) A retail pharmacy may outsource prescription drug order dispensing to another retail or nonresident pharmacy provided the pharmacies:
 - (a) have the same owner or;
 - (b) have entered into a written contract or agreement which outlines the services to be provided and

- the responsibilities and accountabilities of each pharmacy in compliance with federal and state laws and regulations; and
- (c) share a common electronic file or have appropriate technology to allow access to sufficient information necessary or required to dispense or process a prescription drug order.

Centralized prescription dispensing must comply with the above 16.19.6.

§ 1306.15 Provision of prescription information between retail pharmacies and central fill pharmacies for prescriptions of Schedule II controlled substance

§ 1306.27 Provision of prescription information between retail pharmacies and central fill pharmacies for initial and refill prescriptions of Schedule III, IV, or V controlled substances

New Mexico PMP Gateway Integration

The Board continues to integrate the prescription monitoring program (PMP) system into eligible health care software systems across the state. The goal is to increase PMP utilization for both prescribers of CS and pharmacists ("providers") by providing seamless access to a patient's queried PMP report. PMP Gateway integrates PMP

dates within a provider's workflow. The Board, in collaboration with the New Mexico Department of Health and through federal grant funds, purchased a subscription to the PMP Gateway for health care entities that successfully integrate before August 31, 2027. The paid subscription for a health care entity begins the date PMP Gateway

integration is approved by the New Mexico Board of Pharmacy (on or before August 31, 2027) and will renew on an annual basis through at least August 31, 2027. Rule Updates

During the July meeting, the Board approved the following rule updates:

16.19.5 NMAC – Internship Training
Program – Sections 1 and 5 had
administrative updates. Section 8
updated and removed unnecessary
or obsolete provisions and removed
the suspension of preceptor
certification upon change of
employment. Section 9 was deleted
(summary of objectives for last
year's pharmacy students in the rural
health care setting), as all provisions
in that section are otherwise allowed
without additional requirements of
the previous Section 9.

16.19.30 NMAC - Compounding of Non-Sterile Pharmaceuticals

Section 6 had an administrative update. Section 7 added a provision that a flavoring agent subject to certain characteristics is not compounding. Section 9 updated beyond-use dating specifications for consistency with the updated United States Pharmacopeia (USP) chapter for nonsterile compounding. Section 10 changed formulation records to master formulation records, aligned requirements with USP, and aligned requirements of compounding records with USP.

16.19.36 NMAC – Compounded
Sterile Preparations – Section7
removed, updated, and added
definitions for consistency with
updated USP chapters for sterile
compounding. Section 8 clarified
that a consultant pharmacist for
in-state clinics would be responsible
for the duties of the otherwise
pharmacist-in-charge. Sections 9,
10, 11, 13, and 15 were updated for
alignment with USP.

Submit Adverse Drug Event reports to the Board within 15 days of discovery. This is required by rule, and noncompliance may result in disciplinary action. Reports must include an appropriate root cause analysis with corrective action.
