#### **NABP Annual Meeting Update**

The 120th National Association of Boards of Pharmacy® (NABP®) Annual Meeting was held May 14-17 in Fort Worth, TX. "Driving Pharmacy Practice Evolution Together" provided board of pharmacy members and staff, as well as other stakeholders, with an opportunity to take an active role in protecting public health.

Continuing education (CE) topics included pharmacy personnel burnout, artificial intelligence and health informatics, and an emerging pharmacy topic discussion. Corey Feist of the Dr. Lorna Breen Heroes' Foundation delivered the keynote, which challenged attendees to make health care professional well-being a top priority.

Delegates from the member boards adopted resolutions on drug shortages, expanding access to NABP competency assessment examinations, and developing a national forum for pharmacy professional recovery programs. District of Columbia Board Member Dr Allison Hill served as DC's

#### DC Health and the Board Relocated to Ward 8


