Note From NABP: FDA Grants DSCSA Exemption to Connected Trading Partners

On October 9, 2024, Food and Drug Administration (FDA) announced that it has granted an exemption from the enhanced drug distribution security requirements of Section 582 of the Federal Food, Drug, and Cosmetic Act (FD&C Act) for eligible trading partners. While NABP is still evaluating the exemption, the following information highlights its critical components:

- Who is affected: Trading partners who have initiated their systems and electronic data connections, but who still face challenges with missing, incomplete, or inaccurate data.
- What is exempted: Key interoperable Drug Supply

Chain Security Act (DSCSA) requirements that were part of the previous stabilization period, like exchanging transaction information and statements electronically, including product identifiers at the package level and certain verification request requirements.

Timeline:

- For manufacturers and repackagers, exemptions last from November 27, 2024, until May 27, 2025.
- For wholesalers, exemptions are granted until August 27, 2025.

- For dispensers with 26 or more full-time employees, the exemption period extends until November 27, 2025.
- Scope: These exemptions apply to specific requirements under Section 582(g)(1) of the FD&C Act. Other existing DSCSA obligations remain in effect. Notably, trading partners who have not yet initiated the required systems are not covered by these exemptions.

Moreover, the four operational imperatives that NABP has been emphasizing are still required and in effect:

- Know your prescription drug suppliers (sources).
- 2) Know where your product tracing, also known as transaction information (data), is being stored and how to access it.
- Know what a suspect product is, how to identify

- it, how to investigate it, and what to do if it is deemed illegitimate.
- Develop, update, and adhere to robust prescription drug purchasing policies and procedures that accurately reflect your internal processes.

Rule Updates

During the October New Mexico Board of Pharmacy meeting, the following rule update was approved:

16.19.4 New Mexico Administrative Code - Pharmacist

 Sections 7 and 9 added "standard of care" to definitions and "failure to meet standard of care" to the definition of unprofessional or dishonorable conduct. As proposed, "standard of care" means care provided by a licensee within the accepted standard of care provided in the same or similar setting by a reasonably competent and prudent licensee or registrant

with similar education, training, and experience. The proposed change will enable the Board to regulate based on a contemporary construct consistent with advances in pharmacy practice, rather than circumstance-specific rules.

(NCA) settlement agreement. Licenses are on probation for three years. Respondent will ensure the consultant pharmacist conducts quarterly visits, ensure there are procedures and systems in place to prevent and detect controlled substance diversion, and pay a fine of \$1,750 within 90 days.

Lowell Kirk Irby, RP00004822. Pre-NCA settlement agreement. Respondent shall fulfill all responsibilities as a consultant pharmacist for every facility the

respondent serves, in accordance with applicable rules.

Mesilla Valley Pharmacy, PH00004754. Pre-NCA settlement agreement. Respondent shall implement a corrective action plan addressing error prevention, compounding policies, procedures, and training and pay a \$5,000 fine within 90 days.

Marcus Reid, PT00008685. Reject pre-NCA. Summary suspension of pharmacy technician registration for NMHPWP noncompliance.
