#### **PharmaDrop Drug Take-Back Program**

The Board established a drug take-back program in 2017 to reduce the avenue of diversion created by unused, unwanted, and expired drugs in an individual's medicine cabinet. PharmaDrop receptacles, by Trilogy MedWaste, Inc, were placed in South Dakota hospitals and retail pharmacies. The PharmaDrop program was initially funded through a federal prescription drug monitoring program (PDMP) grant and is currently funded by a federal grant from the South Dakota Department of Social Services. Since its inception, the program has placed 87 permanent drug take-back receptacles across the state and has enrolled an additional five locations with preexisting receptacles in the

South Dakota PharmaDrop program, bringing the total number of locations managed by the program to 92. A comprehensive list of permanent drug take-back sites can be found at letsbeclearSD .com under the Prevention heading by selecting Safe Medication Disposal. This program provides an option for the safe disposal of an individual's nonprescription and prescription drugs, including controlled substances (CS), and is a key component of South Dakota's strategy to address misuse, abuse, and diversion of controlled prescription drugs. #### Free PDMP CE for All Pharmacy Staff

The National Association of State Controlled Substances Authorities and 12 state PDMP administrators have, once again, collaborated on a free Accreditation Council for Pharmacy Education-accredited educational opportunity that provides one hour of continuing education (CE) for pharmacists and pharmacy technicians. This program analyzes the importance and value of complete, accurate data reported by dispensers to PDMPs and assesses the impact of intentional or unintentional data entry errors and

data omissions on patient safety. It also discusses the downstream impacts of pharmacy-reported PDMP data on clinical decision-making processes and helps pharmacy staff identify and implement changes that can be made in their practice setting to improve PDMP data integrity. PDMP staff encourages all South Dakota pharmacy staff to visit Talem Health's website and take the course. If you received credit for this CE prior to October 20, 2024, you are still able to retake the CE and receive credit.

## Donated Prescription Drug and Medical Supply Redispensing Program Update

In early 2024, the Donated
Prescription Drug and Medical
Supply Redispensing Program
officially launched. The Board
would like to provide a review and
update on the program now that it
has been in place for nearly a year.
The program may be new to some,
so a quick review of the details is
beneficial.

Medications that may be accepted into the program must be in their original sealed packaging, which must include a lot number and expiration date, and show no signs that the packaging has been tampered with. Donated medical supplies must also be in unopened or sealed packaging with no signs of being tampered with. For this program, CS may not be accepted as donations, and medications that require storage conditions other than room temperature are also not eligible for donation. It is the responsibility of the accepting pharmacy to ensure that all criteria (outlined in Administrative Rules of South Dakota 20:51:35) are met.

The pharmacy must also thoroughly inspect and document each donation by completing the Donation Record form on the Board's website.

Patients eligible to receive a donated product are those who are indigent or lack third-party coverage for a prescribed medication/supply and include any other individual who can use an item donated to the program. All federal and state laws must be followed for the dispensing of any prescription drugs or supplies from the program. A partnership with Optum Perks, LLC, has been established for the dispensing pharmacy to process the claim. When submitted, the claim will be processed free of charge to the patient. Participating pharmacies are provided with details related to Optum upon entering the program. Dispensing pharmacies may charge the recipient a handling fee of up to \$25 for mailing, handling, or dispensing costs. Upon the program's dispensing of a medication or supply, a Dispensing/ Recipient Record form must be filled

out and signed by the patient and dispensing pharmacist.

At this time, there are 46 pharmacies signed up to accept donated prescription drugs and supplies and nine pharmacies that can dispense the donated items to patients. The Board encourages pharmacies to participate in this program, as it has the potential to help patients across our state. Even if you are not a participating pharmacy, you can still access the Directory on the Board's website, which lists the participating pharmacies and available products. If you have a patient in need of a product on the directory, contact the respective pharmacy listed and coordinate with them.
