DC License Renewal for Pharmacists and Pharmacy Technicians

The License Renewal Portal is now open, and the deadline to renew is February 28, 2025. The pharmacist renewal fee is \$310, and pharmacists are required to complete a minimum of 40 contact hours of continuing education (CE) in approved programs from March 1,

2023, through February 28, 2025. CE credits must include the following:

- At least two hours in medication/ dispensing errors;
- At least two hours in cultural competency or specialized clinical training focused

on patients or clients who identify as lesbian, gay, bisexual, transgender, gender nonconforming, queer, or questioning their sexual orientation or gender identity and expression (LGBTQ); and

 At least 10% of the total required CE hours shall be in the subjects determined by the director as public health priorities of the District every five years, or less frequently, as deemed appropriate by the director, with notice of the subject matter published in the DC Register.

Pharmacists will be required to submit their NABP e-Profile® number during the renewal process and must also be registered for the District's Prescription Drug Monitoring Program.

Pharmacists with certification to administer immunizations and vaccinations are required to maintain

current certification in CPR for health care providers and complete two hours of relevant CE. There is an additional \$50 fee required for vaccination and immunization certification.

The pharmacy technician renewal fee is \$50 and pharmacy technicians are required to complete a minimum of 20 contact hours of CE in approved programs from March 1, 2023, through February 28, 2025. CE credits must include the following:

- At least two contact hours in pharmacy law;
- At least two contact hours in medication safety;

- At least two hours in cultural competency or specialized clinical training focused on patients or clients who identify as LGBTQ; and
- At least 10% of the total required CE hours shall be in the subjects determined by the director as public health priorities of the District every five years, or less frequently, as deemed appropriate by the director, with notice of the subject matter published in the DC Register.

Please note that the CE requirements do not apply to pharmacists or pharmacy technicians renewing their licenses for the first time.



Update to License Renewal Periods

Please note that starting this renewal period, renewed licenses will now expire on the last day of your birth month. Furthermore, the expiration date will coincide with your birth year. If your birth year falls in an odd year, your license will expire in the next odd year. Similarly, if your birth year falls in an even year, your license will expire in the next even year. This change applies to all renewal applicants.
