#### **Updates to SDCL 36-11 and SDCL 36-11A**


As of July 1, 2025, updates to South Dakota Codified Laws (SDCL) related to pharmacy practice have taken effect. One change pertains to the late fee for pharmacists, pharmacies, and wholesalers. If the license for a pharmacist, pharmacy, or

wholesaler is not renewed by the deadline for each license type, a \$50 late fee will be applied. In addition to the late fee, the South Dakota Board of Pharmacy is working on a rule update package that includes increasing the wholesale license fee to \$500. This

### Updates to ARSD 20:51 and ARSD 20:67

The Board is currently working on a rule update package that will include increasing wholesaler fees, technician certification requirements, updates to emergency kits in nursing facilities, and other updates discussed at previous Board meetings. These rule updates relate to Administrative Rules of South Dakota (ARSD) 20:51 and ARSD 20:57 and will be available on the Board's website. 





#### **PDMP Update**

#### **Trending Opioid Prescriptions to SD Patients**







These graphs show trends in opioid prescriptions dispensed to South Dakota patients over the last three years – 2022, 2023, and 2024:

- The prescription count has increased slightly.
- The total quantity dispensed has decreased overall and is almost level over the prior two years.
- · The total days of supply has increased.

#### These trends suggest:

- opioid prescriptions in South Dakota may have reached the level required to ensure that appropriate pharmaceutical therapy is being provided to South Dakota citizens, and
- past inappropriate prescribing and overprescribing have been identified and addressed with the use of the prescription drug monitoring program (PDMP), as is shown by quantity and days of supply trends.

As a point of reference, these three metrics included the following in 2015:

- 1) prescription count equaled almost 710,000, so there has been a 38% decrease to 2024;
- total quantity dispensed equaled almost
  million doses, so there has been a 54% decrease to 2024; and
- 3) total days of supply equaled almost12 million days, so there has been a 47% decrease to 2024.

Efforts must be maintained, including ongoing promotion of PDMP utilization, to continue the perceived successes shown by these decreased metrics over the past 10 years.
